Travel-Net Communications Inc. will not be responsible for any damage you suffer, this includes the loss of data resulting from delays, non deliveries, miss deliveries, or service interruptions caused by its own negligence or your errors or omissions. Use of any information obtained via Travel-Net Communications Inc. is at your own risk. Travel-Net Communications Inc. specifically denies any responsibility for the accuracy or quality of information obtained through its services.
- Travel-Net Communications Inc. may only be used for lawful purposes. Transmissions of any material in violation of any Canadian or provincial regulation is prohibited. ### **Payment Terms:**

- Payment to be made on the first day or every month either by pre-authorized payment or on receipt of invoice, payment shall be made by cheque, credit card or cash payable to Travel-Net Communications Inc. If the new balance is not paid in full, a credit charge will be added at a rate of 1.75% per month. No payment is assessed if payment in full is received within 7 days of the invoice date. Travel-Net Communications Inc. reserves the right to restrict, suspend or cancel at any time.
